or contact Chrislyn Villena, our parish Youth Minister This is a detailed review of the St. Joseph Hilo Parish Fiscal Year End June 30, 2020 financials.

Review of our Parish annual financial report will reveal a substantial decrease in revenues attributed to the several months with no services and from lower attendance and subsequent offerings at services with limited capacity attributed to COVID restrictions.

Savings on expenditures did minimize the negative net revenues. Employment costs are lower with the long-term leave of our receptionist. Supplies & other services have decreased as the parish is no longer printing the Sunday bulletin and general restrictive purchases of supplies for the church and the office. Repairs & maintenance dropped as the painting of the Church and other major repairs happened in fiscal year ending 6/30/2019.

Insurance premiums rose attributed to increases in the diocesan insurance premiums. The other noticeable increase is the Parish assessment to the Diocese. There was increase for all parishes for last fiscal year. There is a decrease this fiscal year, back down to the previous year's level.

Temporarily restricted donations include 2 major items. One consists of donations to the repair and maintenance fund. These donations have been used for all repair and maintenance of the Parishes main property (the Church and rectory). The other main contribution is the rental income from the convent across the street from the school. The terms of the ground lease require the property to be used for educational purposes. As such, lease income from the convent is directed to the school.

In your review of the balance sheet you will notice a satisfactory cash position. Note that the

\$502,221 in restricted funds is included in this balance. The reason there is a respectable cash balance is because of the Payroll Protections Program (PPP) loan which will be discussed below. There are a couple noticeable changes to mention. These are in the liability section of the balance sheet. The main reason for the increase in accounts payable is attributed to transactions between the Parish and the school which have since been cleared. The increase in other current liabilities is attributed to the PPP loan with a balance of \$41,960 as at 6/30/2020. The forgiveness application is being submitted by the diocese. Deferred rental income relates to income from the apartments not paid in exchange for the tenant (Hope Services) to replace the roof.

The question now is what will happen as the parish continues through the COVID restrictions and collection revenues are down 33+%. Presently the parish has 3 lay employees and covers the contract cost for 2 priests. That expense continues. Without a receptionist, volunteers have assisted in the office. There may be a need to shorten the hours the office is open to the parishioners to give staff the opportunity to get their regular work done. The other shortfall is with repair and maintenance. Volunteers have taken responsibility for keeping the Church and rectory properties clean and sanitized. But is this sufficient and sustainable for the long term? Currently religious and office supplies are satisfactory. If this is sustainable your parish will make it through these tough times. A recovery to normal collections is not projected to rebound soon. Perhaps it will be another year. State economists project the state will not have pre-covid employment levels until 2023 We continue to have restricted attendance at Mass and with many continue to be out of work.

Over the next couple week Fr. Poli will be presenting a recap of how the Parish has excelled in its religious and community activities. Your Parish continues to serve.

All parishioners are called to help with treasure, talent and time. If you see a need, mentioned to the priest and see what you can do to satisfy that need. Many times it is a matter of contributing time and talent. This is a community of Catholics who worship together. As a community, let each one of us find our niche, our kuleana, and help out. Together, as a community working together St. Joseph Parish in Hilo, and St. Joseph School will evolve to grow in numbers and thrive. Be proud of your parish. If you have not done so yet, find your way to actively participate in your Catholic community.

Aloha, Sisters and Brothers! Peace be with you!

This year of 2020 has brought us many unprecedented experiences and major adjustments to our lives and livelihoods due to the coronavirus pandemic. While we must not let down our guard and continue to observe prudent hygiene measures, we also want to look optimistically to the future.

With Advent and Christmas coming, it is very important that we prepare ourselves well for these high holy days in which we celebrate the great gift of the Word of God taking flesh and dwelling among us. Therefore, I ask all the parishes to plan their Advent and Christmas schedules in such a way as to accommodate as many people as possible throughout these days.

Since mid-March through October 31, 2020 I have issued a dispensation from the obligation to attend Mass on Sundays in order to prevent the spread of COVID-19. I am hereby extending that dispensation from the obligation to attend Mass on Sundays and holy days of obligation through December 31, 2020. As I do so, however, I urge everyone who is able to return to Mass, without undue risks to their health or the health of others, to do so.

Please note that in the Diocese of Honolulu, besides all Sundays, the holy days of obligation are the Solemnity of the Immaculate Conception on Tuesday, December 8; and Christmas on Friday, December 25. Again, while all are dispensed from the obligation of attending, I urge you to do so if you can.

It is highly recommended that those who do avail themselves of the dispensation substitute some other prayer experience so that worship of God does not lose its primary focus in our lives. One could do a home holy hour, pray the rosary, celebrate the Liturgy of the Hours, or do some reading of spiritual books and articles, especially the lives of the saints. Of course, we also encourage anyone who cannot attend Mass to watch a live-streamed Mass. Sites are posted on our diocesan website at www. catholichawaii.org.

We encourage everyone to reach out to those who may not hear this message on their own and invite them to "Come, let us adore him, Christ the Lord!"
